

RESOLUTION NO. 2014-11

A RESOLUTION TO PROVIDE FOR THE REMOVAL OF ICE, SNOW, AND FALLEN BRANCHES FROM THE STREETS OF THE VILLAGE OF RIVERLEA

WHEREAS, the Council of the Village of Riverlea has determined it is in the best interest of the Village to provide for the removal of ice, snow, and fallen branches from the streets of the Village;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF RIVERLEA, STATE OF OHIO:

Section 1. AUTHORIZATION. That the Mayor be and is hereby authorized and directed on behalf of the Village of Riverlea, Ohio, to enter into an appropriate Snow, Ice, and Fallen Branch Agreement with Sharon Township and the Sharon Township Trustees to remove ice, snow and fallen branches from the streets of the Village, beginning upon the effective date of this Resolution and ending when the contract is terminated by either party; provided that the amount expended therefor pursuant to this Resolution **shall not exceed \$_____ per year**; that the Village request a prompt billing from the Sharon Township Trustees for the cost of labor, equipment and material used in such snow and ice removal, and that such costs be paid promptly upon the receipt of an invoice therefor.

Section 2. APPROPRIATION. That the funds necessary to carry out the purposes of this Resolution have heretofore been appropriated.

Section 3. EFFECTIVE DATE. That this Resolution shall be in full force and effect from and after the earliest date permitted by law after its passage.

Section 4. OPEN MEETINGS. This Council finds and determines that all formal actions of this Council concerning and relating to the passage of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council that resulted in those formal actions were in meetings open to the public in compliance with law.

Section 5. PUBLICATION. That pursuant to Ohio Revised Code Section 731.25, the Council of the Village of Riverlea hereby determines that publication of this Resolution in a newspaper is unnecessary and does hereby determine that this Resolution shall be published by posting copies hereof in the five following places, which are determined to be the five most public places in the Village of Riverlea, Ohio:

1. The Circle on West Riverglen Drive.
2. The Ravine Park on West Riverglen Drive.
3. The Northwest corner of Beverly Place and Dover Court.
4. Lot 75 on West Riverglen Drive.
5. Lot 7 on West Southington Avenue.

Copies of this Resolution shall be posted continuously in the above-mentioned places for a period of fifteen (15) days and at the expiration thereof this Resolution shall become effective.
