

ORDINANCE NO 01-2023

AN ORDINANCE TO PROVIDE FOR THE
COMPENSATION OF VILLAGE COUNCILMEMBERS,
CERTAIN ELECTED OFFICERS, AND APPOINTED
OFFICIALS OF THE VILLAGE

WHEREAS, the Village of Riverlea has determined that certain increases in the annual compensation of Village Councilmembers, elected officers, and appointed officials of the Village are appropriate, given the length of time that has elapsed since such compensation was last adjusted; and

WHEREAS, it has been determined that there is sufficient anticipated revenue to provide for such compensation increases to said Councilmembers, officials, and officers,

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE
VILLAGE OF RIVERLEA, COUNTY OF FRANKLIN, STATE OF OHIO:

Section 1. ESTABLISHMENT OF COMPENSATION. That Ordinance 771, Ordinance 845, Resolutions No. 2008-08 and Resolution No. 2008-18 be amended, to state that Village Councilmembers, elected officers, and appointed officials will receive the following compensation:

Mayor (now \$6,000):	New: \$9,500
Clerk-Treasurer (now \$12,000):	New: \$15,500
Each Councilmember (now \$450):	New: \$700
Council President (now \$775)	New: \$1,000
Planning Commissioner (now \$1,800)	New: \$2,500
Street Commissioner (now \$1,800)	New: \$2,500


Section 2. DATE OF COMMENCEMENT. That the new compensation rates will go into effect on January 1, 2024.

Section 3. PUBLICATION. That pursuant to Ohio Revised Code Section 731.25, the Council of the Village of Riverlea hereby determines that publication of this Ordinance in a newspaper is unnecessary and does hereby determine that this Ordinance shall be published by posting copies hereof in the four following places, which are determined to be the five most public places in the Village of Riverlea, Ohio:

1. The Circle on West Riverglen Drive.
2. The Ravine Park on West Riverglen Drive.
3. Lot 194, 286 Beverly Place.
4. Lot 75 on West Riverglen Drive.
5. Lot 7 on West Southington Avenue.

Copies of this Ordinance shall be posted continuously in the above-mentioned places for a period of fifteen (15) days and at the expiration thereof this Ordinance shall become effective.


