

ORDINANCE NO 04-2022

Approving an Amendment to Riverlea Code of Ordinances Chapter 78: PARKING SCHEDULES, Schedule 1, Parking Prohibited, to reduce the parking prohibition from High Street west to Crescent Court on West Riverglen Drive.

WHEREAS, the Village of Riverlea has determined that the current parking prohibition on West Riverglen Drive listed in the Riverlea Code of Ordinances, Chapter 78, PARKING SCHEDULES, Schedule 1, extends too far west on Riverglen Drive; and,

WHEREAS, in connection with the apartment buildings on W. Riverglen having a limited number of parking spaces, it has become necessary to provide for more parking on W. Riverglen; and,

WHEREAS, Village Council wishes to change the parking prohibition in Schedule 1, PARKING PROHIBITED, that currently states that parking is prohibited on West Riverglen Drive "From High Street west to Crescent Court";

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Riverlea, County of Franklin, State of Ohio:


Section 1. AMENDMENT. That Ordinance Ch 78, PARKING SCHEDULES, SCHEDULE 1. PARKING PROHIBITED be amended, in row 2, to state that parking on West Riverglen Drive is prohibited on the North side of W. Riverglen Dr. from High St. to west of the intersection of Crescent Ct. and W. Riverglen Dr. Parking is also prohibited on the South side of W. Riverglen Dr. from 60 feet of High St., and between the driveway for 5819-5825 W. Riverglen and Crescent Court.

Section 2. PUBLICATION. That pursuant to Ohio Revised Code Section 731.25, the Council of the Village of Riverlea hereby determines that publication of this Ordinance in a newspaper is unnecessary and does hereby determine that this Ordinance shall be published by posting copies hereof in the four following places, which are determined to be the five most public places in the Village of Riverlea, Ohio:

1. The Circle on West Riverglen Drive.
2. The Ravine Park on West Riverglen Drive.
3. Lot 194, 286 Beverly Place.
4. Lot 75 on West Riverglen Drive.
5. Lot 7 on West Southington Avenue.




