

ORDINANCE NO. 04-2025

AN ORDINANCE TO AMEND CHAPTER 93.42, NOTICE TO CUT WEEDS  
OR REMOVE LITTER FOR THE VILLAGE OF RIVERLEA

Introduced by Amick.

WHEREAS, the Council for the Village has determined that an update is needed to Chapter 93.42 of the Code of Ordinances, to clarify that the requirements to cut weeds or remove litter in the Village.

**BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF RIVERLEA, STATE OF OHIO:**

SECTION 1. That Chapter 93.42 NOTICE TO CUT WEEDS OR REMOVE LITTER, be amended to read as follows:

**93.42 NOTICE TO CUT WEEDS OR REMOVE LITTER AND TRASH.**

**(A) When determined by the Mayor or a representative of the Mayor that 93.41 is being violated, the Mayor or the Mayor's representative will notify the owner and any other person responsible for the property that they are in violation of this subchapter and that they must cut or destroy the noxious weeds within 5 days of the receipt of notice, or remove the litter and trash within 7 days of the receipt of notice.**

SECTION 2. OPEN MEETINGS. This Council finds and determines that all formal actions of this Council concerning and relating to the passage of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council that resulted in those formal actions were in meetings open to the public in compliance with law.

SECTION 3. PUBLICATION. That pursuant to Sections 731.25, Ohio Revised Code, the Council of the Village of Riverlea hereby determines that publication of this Resolution in a newspaper is unnecessary and does hereby determine that this Resolution shall be published by posting copies hereof in the five following places which are determined to be the four most public places in the Village of Riverlea, Ohio:

1. The Circle on West Riverglen Drive.
2. The Ravine Park on West Riverglen Drive.
3. Lot 194, 286 Beverly Place.


4. Lot 75 on West Riverglen Drive.
5. Lot 7 on West Southington Avenue.

Copies of this Resolution shall be posted continuously in the above-mentioned places for a period of fifteen (15) days and at the expiration thereof this Resolution shall become effective.


