## **ORDINANCE NO. 01-2016**

## AN ORDINANCE TO APPROVE A MODIFICATION AND REALIGNMENT OF ORDINANCE 11-2015, THE ANNUAL APPROPRIATION ORDINANCE (VILLAGE), AND TO DECLARE AN EMERGENCY

WHEREAS, Council for the Village having determined that it has become necessary further to alter the 2016 Appropriation for the Village of certain funds thereof in order to permit expenditures that will fund fully certain activities of the Village, provided that such alteration will not cause the appropriations for such accounts and funds to exceed the official estimate of resources, all for the fiscal year ending December 31, 2016;
