Regular Meeting

September 21, 1982

Mayor Guthery called the meeting to order at 7:30 p.m.

Present: Council members Betts, Edwards, Hallock, Merrick, Owens and Thrall;  
Solicitor Scott Jamieson; Treasurer Ken Armagost; Newsletter editor  
Henrietta Stabler; and Clerk Mary Lou Young.

The Clerk read the minutes of the meeting of June 21, 1982, and also the minutes of the emergency meeting of August 30, 1982. The minutes were approved as read.

Mr. Owens moved and Mrs. Thrall seconded that the bills be paid as read.  
Unanimous vote "aye."

The Mayor presented a request for Council approval of a ticket purchase for the Mayor's Council dinner. She also informed Council that a PUCO issue is to be discussed there. Bill for the Ohio Municipal League Conference and Moody's Paper Store were approved for payment. Mr. Betts moved and Mr. Owens seconded that the bills be paid. Unanimous vote "aye."

Mr. Armagost read the Treasurer's Report as attached. There was discussion of the Federal Revenue Sharing Fund which is \$2,572.51. Use must be sanctioned by a public meeting and approval of citizens. Committee to be established to discuss use of the fund. Mayor appoints Mr. Owens, Mr. Armagost, and Mr. R. Beyer. Mr. Hallock suggested road surface repair as a possible use of the money. Meeting may be combined with public meeting regarding the tree committee. There being no further discussion, the report will be filed for audit.

Mrs. Thrall informed Council that some young Riverlea residents had proposed to mow the park and would offer less than Mike Grubb had been charging. Tabled till March 1983 to be reassessed. Council asked for proposal in writing from the young people.

After some discussion about the problem of cats trespassing on residents' property, Solicitor Scott Jamieson agreed to write a letter stating the ordinance against stray animals would be enforced. \*

Mr. Merrick, Mrs. Thrall, Mr. Edwards met with Mr. Andrew P. Todd of the Ohio Department of Natural Resources to discuss technical assistance to the village and individual residents on tree care, tree planting. A replacement plan was discussed for trees in the Village as they die. The tree committee suggests that a slide show of trees could be presented next spring at a public meeting and this could be combined with the proposed meeting on revenue sharing.

QUBE sent correspondence that stated that the rate per month will be raised from \$9.00 to \$9.95. Discussion was held and the Solicitor stated that public hearing is permitted on such a raise but any protest would probably not be effective since QUBE could show that inflation justified the increase.

The Citizens for Excellence in Education wrote a letter seeking endorsement of Council for an increase in taxes to support the Worthington school system. After some discussion the Council voted to act on the endorsement.

Ordinance 520 for collection of trash was presented and a vote taken to declare an emergency and suspend three readings of the ordinance. It was moved by Mr. Merrick and seconded by Mr. Owens. Unanimous "aye." The ordinance was passed providing for collection of trash in the village from October 1 to December 31, 1982. Mr. Edwards moved and Mrs. Thrall seconded. Unanimous vote "aye." 520

The Mayor reported that action on applying for funds to use for ice and snow removal by writing to the County Commissioners has been originated.

A discussion took place regarding the date of delivery of leaf bags, and it was decided to pay for delivery to each home. Estimated cost was about 50¢ per home in Riverlea, or \$114.00. Final delivery date will be October 9th and additional bags will be available on the 23rd of October at the Circle on Riverglen. The bags are to be ordered in two lots of 4,000 -- total 8,000 bags.

Ordinance 521 was read and passed regarding the provision of signs for the driveway of the condominiums on High Street. The residents of the condominiums

had requested the signs because the public is using their driveway thinking it exits onto Southington. Mr. Owens moved and Mr. Hallock seconded that an emergency be declared and the required three readings of the ordinance be suspended. 521  
Unanimous vote "aye." Mr. Edwards moved and Mr. Merrick seconded that the ordinance be passed, providing for a No Outlet sign for the driveway through the condominiums. Unanimous vote "aye."

New Business: Discussion took place regarding the car for sale on the boulevard at the end of Southington near High Street. Mr. Edwards offered to mention this car to the owner of the apartment, Charles Brown, and Solicitor Jamieson agreed to write to Mr. Brown regarding the matter.

There being no further business, meeting adjourned at 9:25 p.m.

Regular Meeting

October 18, 1982

Mayor Guthery called the meeting to order at 7:30 p.m.

Present: Council members Betts, Edwards, Merrick, Simmons, Owens and Thrall; Solicitor Scott Jamieson; Treasurer Ken Armagost; Newsletter editor Henrietta Stabler; and Clerk Mary Lou Young.

The Clerk read the minutes of the last meeting of September 21, 1982, and Mr. Merrick proposed a correction on Page 2 in the paragraph regarding the Citizens for Excellence in Education. The sentence reading "After some discussion the Council voted to act on the endorsement," was amended to read: "After some discussion the Council took no action on the endorsement."

The Clerk read the bills paid since September 21, 1982, as follows:

The bill to Worthington Hardware for leaf bag ties was questioned since the bags came with ties enclosed. Mr. Betts offered to check the purchase and report back to Council. Otherwise, Mr. Edwards moved and Mrs. Thrall seconded that the bills be approved as read. Unanimous vote.

Mr. Armagost read the Treasurer's report as attached. The report will be filed for audit.

Col. Simmons read the Marshal's report for the last four months:

June:	898 miles driven, 180 hours on duty, 235 house checks
July:	942 miles driven, 186 hours on duty, 327 house checks
Aug.:	965 miles driven, 202 hours on duty, 416 house checks
Sept.:	894 miles driven, 180 hours on duty, 292 house checks

Col. Simmons also reported a letter on file at the Franklin County Sheriff's Department regarding the status of Col. Simmons as Marshal of Riverlea and read the letter outlining the responsibility and limits of the position.

Solicitor's Report: Scott Jamieson reported he contacted Mr. F. Ball of the City of Worthington regarding an additional traffic light being needed at High and Southington. Regarding hiring of young people for mowing, he reported that Ohio law stipulates that no one under 16 may operate a power machine on public lands.

Mr. Betts reported that leaf bag delivery went well, with no problems. Further distribution will take place on the circle on Riverglen on Oct. 23 from 10-2 p.m. Some discussion also took place as to alternative means, such as a leaf picker, to retrieve leaves and also of selling the bags to residents next year due to the high cost of bags. No final decision was made.

Mayor Guthery reported that the Gingerbread House on High Street had been bought for \$85,000 and will be restored by the new owner.

Mayor Guthery asked for a vote to approve purchase by council of a \$6.25 ticket for a luncheon held by the Columbus City Attorney's Office regarding contracts. Council President Tom Betts to attend. Mrs. Thrall moved and Mr. Owens seconded that this be approved. Unanimous vote.

The Mayor read the information from Ohio Municipal League regarding revenue bonds and other issues. After discussion, Council took no action on endorsing the issues.

The Budget Commission: 1983 budget figures for the Village of Riverlea were read by the Clerk. The resolution to approve the budget as read was moved by Mr. Owens and seconded by Mr. Merrick. Unanimous vote.

Resolution 522 increasing appropriations in the Board of Elections fund and in the Clerk - Code 70 "Other" fund was read by the Clerk. After some discussion Mr. Edwards moved and Mr. Betts seconded that the resolution be approved. Unanimous vote. 522

Mr. Edwards discussed the proposed contract from the Franklin County Sheriff for police service for a 2-year period. The proposed increase is 10%, and the contract detailed the reason for the increase, citing inflated costs. After some discussion regarding negotiating with Worthington and Sharon Township for police services, it was decided the committee (Simmons, Merrick, and Edwards) would check the availability and cost of Worthington police service.

Mr. Owens stated that the revenue sharing committee had not reached a decision on a recommendation for using the federal government money available. Suggestions were: shrubbery in the circle, park benches of a permanent nature in the ravine and circle, or an increase in salary for employees.

Mayor Guthery presented information on the public utilities from the Consumer Council. After some discussion Council took no action to endorse any issues. Solicitor Jamieson stated that he would not recommend quick action on public utilities since it requires study.

The Mayor expressed appreciation to Newsletter Editor Henrietta Stabler for a fine Newsletter and the information in the Riverlea Directory. She also

expressed appreciation to Mr. Betts, Mr. Merrick and Mr. T. Beegle for leaf bag distribution.

Resolution 523 was passed "accepting the amounts and rates as determined by the budget commission and authorizing the necessary tax levies and certifying them to the county auditor." D. Owens moved and T. Betts seconded that this resolution be passed. Council voted unanimously in favor of the resolution. 523

There being no further business the meeting was adjourned at 9:05 p.m.

## Minutes

Regular Meeting November 15, 1982

Present: Mayor C. Guthery, Thomas Betts, Dan Owens, Dave Merrick, S. N. Hallock, Alice Thrall, Col. John Simmons, Solicitor Scott Jamieson, Treasurer Ken Armagost, Clerk Mary Lou Young, Newsletter Editor Henrietta Stabler, William Edwards.

The Mayor called the meeting to order at 7:30 p.m.

The Clerk read the minutes of the meeting of October 18, 1982, and Mr. Betts proposed a correction of the name Brugler to Beegle. Otherwise, the minutes were passed with no objection and stand as read.

The bills between the meeting of Oct. 18 and Nov. 15, 1982, were read as follows:

A fee of \$77.00 for membership in the Ohio Municipal League was presented for payment and Council approved after S. N. Hallock moved and Dan Owens seconded that Riverlea participate as a village in the Ohio Municipal League.

After a discussion on whether to wait for payment of bills until they are submitted to Council, it was decided that most bills had been passed previously by ordinance and there is a contract to pay them. Bills which do not fall into this category will be presented to Council.

The Treasurer read his report as attached for the previous month. Mr. Armagost stated that he would like to use the money in the Street fund to purchase a \$5,000 Certificate of Deposit. This was approved by Council. There was a suggestion, read by Mayor C. Guthery, regarding the Treasurer's report, that each Council member have a copy or at least one copy for every three persons at Council meeting. There being no further discussion, the report will be filed for audit.

Marshal's Report: The marshal reported that the total miles driven in the month are 978 miles, 184 hours on duty, and 251 house checks were made. On Beggars' Night the marshal toured the area and found no disturbance of any kind. An additional police cruiser was provided by the Franklin County Sheriff's Office.

Mrs. Thrall reported that a burglar alarm had been ringing at a residence on Melbourne Place and the police officer did not respond to check it even though he was in the area. The officer stated that the alarm had rung previously as a "false alarm" and he did not feel it necessary to check on it.

Streets Report: Mr. Edwards reported that there was no news, but there was some discussion about the condition of the resurfaced Riverlea streets. Mr. Edwards stated that the warranty has probably expired on the streets and therefore there would be no compensation for repairs. There was discussion of resurfacing every two years; however, discussion also mentioned that the sealer on the streets is supposed to last 5 years and therefore there should not be a need for it to be done more frequently.

Report on City Attorney's Meeting: Mr. Betts reported on the Columbus City Attorney's luncheon. The City of Columbus is offering Riverlea the service of prosecutors at \$40.00 an hour in the night court. He also reported that Riverlea has not delivered a list of the ordinances to the Prosecutor's Office and that for the prosecutors to serve Riverlea the ordinances should be on the books. There was a resolution that the contract be undertaken through the Prosecutor's Office particularly to enforce criminal and traffic ordinances. Mr. Betts mentioned that Council should make a review of ordinances and bring them up to date.

Scott Jamieson, solicitor, recommended that the resolution to enter into contract with the Prosecutor's office be passed, and after some discussion Mr. Hallock moved and Owens seconded that the resolution be passed to enter into contract with the Prosecutor's office. There was a unanimous vote. *(Resolution 527)*

Solicitor's Report: Mr. Jamieson reported that he had received a telephone call from Dr. M. Hilty's attorney, Mr. Hornbeck, regarding the sewer easement on the lot owned by Mr. Hilty known as Reserve B. Mr. Hornbeck stated that Dr. Hilty would take steps to move the easement to meet code requirements of the village. There is a possibility that he would be present at the December Council meeting to discuss this. Discussion centered on the necessity for the village to have access to the storm sewer and the fact that the village would take no share in the cost of moving the storm sewer.

New Business: Mr. Edwards stated he had two pieces of correspondence, one from the Consumers Council regarding gas rates, another from the Mayors Council from Mayor John K. Francis of Reynoldsburg informing the village that a portion of the uniform tax fund could be refunded to the municipality. The amount put in by the Village of Riverlea amounted to \$19.26 and this could be retrieved by showing the warrant paid in 1972. It was moved by Mr. Betts and seconded by Mr. Hallock that Riverlea request the refund. Unanimous vote.

Regarding the gas rates, there was a discussion whether to support House Bill 247, and Mr. Betts read a synopsis which indicated that passage of the bill would raise the gas rate for the Village of Riverlea for Columbia Gas of Ohio. Mr. Betts moved to table the question, Mr. Edwards seconded and it was passed by unanimous vote.

The Clerk read the information regarding the new law that businesses must prove they have paid their business taxes when being accepted for competitive bids for contracts and must present proof of payment of taxes at the time their bid is accepted.

Mr. Betts reported on the situation of leaf bag distribution: he stated 25 per resident were distributed. Leaf bags were redistributed on October 23. There was another distribution on October 30, and Mr. Betts stated he had called all who had asked for bags to inform them of the distribution.

There was a discussion of poster boards and need for latches for the bulletin boxes since they are falling apart. Two street signs were also apparently vandalized and were missing.

There being no further business, the meeting was adjourned at 9:05 p.m.

The Clerk read the bills which had been paid since the November council meeting and Dan Owens moved and Dave Merrick seconded that the bills be approved as read. Unanimous vote.

The Treasurer read his report which is here attached, and since there was no discussion of the report it will be filed for audit.

The Marshal reported for the month of November: 863 miles driven, 180 hours on duty, and 265 house checks. There were no unusual happenings reported.

The Mayor complimented council member Alice Thrall on her choice of two wreaths to decorate the Village for Christmas.

A discussion took place regarding the leaves in gutters in front of residents' homes and the possibility of those leaves clogging the catch basins in the streets. Mr. Edwards suggested a direct approach to property owners regarding this problem rather than contracting to have the streets swept.

Solicitor's Report. The solicitor, Scott Jamieson, reported that ordinances for the City Attorney's office are being gathered together so that criminal and traffic ordinances of Riverlea will be on file at the City Attorney's office.

Mr. Betts presented a letter to Council from MORPSC health planning service for containment of health costs. After discussion, Council took no action on the letter.

New Business. The streets committee (Mr. Edwards, Mr. Merrick and Col. Simmons) met with Dave Elder, the City Manager of Worthington, regarding a 1-year agreement to be entered into with the City of Worthington to contract for police protection at \$2,000.00 a month for basic police service. Detective service, if needed, would be billed separately. For basic police protection the Worthington police will make 6 daily trips by cruiser into the Village. Mr. Edwards also stated that Chief Paul Abbott would be coming to Council meeting to elaborate on the potential contract and answer any questions. (Chief Abbott arrived later at the meeting and outlined the police service offered in the contract.) It was decided by Council that a vote could be taken on approval of the contract between Riverlea and the City of Worthington for police service. The vote would be contingent upon the approval of the contract by the solicitor and his communication of this approval to the Mayor.

The Clerk read Resolution 524A, a resolution providing for the removal of ice and snow from the streets of the Village of Riverlea, Ohio. Dan Owens moved and Dave Merrick seconded that the resolution be approved. Unanimous vote "aye."

The Clerk read Resolution 525, a resolution providing for the cleaning and maintenance of the sump pump and sump-pump house and the inspection of three designated manholes in the Village of Riverlea on a bi-weekly basis. Dave Merrick moved and Mrs. Alice Thrall seconded that the Resolution be approved. Unanimous vote "aye."

The Clerk read Ordinance 526, an ordinance providing for the collection and disposal of garbage and rubbish and declaring an emergency. Thomas Betts moved to suspend the three readings of the ordinance and to declare an emergency. Dave Merrick seconded the motion. Mr. Edwards moved and Mr. Merrick seconded to declare an emergency. Unanimous vote "aye."



The Mayor appointed the Appropriations Committee: The Clerk, Treasurer and Mr. David Merrick.

Mr. Edwards proposed to Council that liability insurance be considered on members of Council, and this is to be considered after figures are submitted by Bartels Insurance Agency.

The final piece of business was to vote on the emergency ordinance 527 to authorize the Mayor to enter into contract with the Worthington Police after approval of contract by the solicitor, and Mr. Wm. Edwards. Owens moved and Edwards seconded to suspend three readings of the ordinance, and Mr. Merrick moved and Mrs. Alice Thrall seconded that an emergency be declared. Unanimous vote "aye."

There being no further business, the meeting was adjourned at 9:15 p.m.
