ELECTION OF COUNCIL PRESIDENT

The Mayor called for nominations. Mr. Janssen nominated Mr. Merrick; Mrs. Anderson seconded. Mrs. Call nominated Mr. Owens; Mrs. Kochalski seconded. The vote, taken by written ballot, elected Mr. Owens President for 1989, four to two.

MINUTES OF PAST MEETINGS

The draft copy of the November 21 minutes were approved as corrected by Mr. Merrick's motion, Mrs, Anderson's second and unanimous vote aye. On the draft copy of the December 19 minutes, in the Mayor's Report the words "with complaints" were deleted following "the person to call." Mr. Owens noted typographical errors, the Solicitor corrected his report regarding solicitation, and under Committee Reports, Broadmeadows Park, the wording was corrected to indicate the City of Worthington is seeking to purchase the area. Mr. Owens called for the approval of the corrected minutes, Mr. Janssen seconded and all voted in favor of the motion.

CLERK-TREASURER'S REPORT

Mrs. Wallace had distributed the Financial Report and the listing of the December bills. Mrs. Kochalski moved, Mrs, Anderson seconded and all voted to pay the following: City of Worthington, police

MAYOR'S REPORT

In her report, Mrs. Huestis told of the Village's being billed for an additional \$1,384.50 by Bituminous Paving Systems, Inc. At her request, Ted M. Beegle has asked that they provide us something in writing as verification of what they did before consideration of payment. She asked the Solicitor to look into this.

MARSHAL'S REPORT

The Mayor read the Police report for December which included two burglaries on Dover Court and an attempted burglary on West Riverglen. She said the Police urge residents to keep lights, especially outside ones, on at night.

COMMITTEE REPORTS

M.O.R.P.C. Mr. Owens attended a presentation on plans for the Quincentennial Celebration in 1992.

AmeriFlora Mrs. Anderson attended a meeting in Lancaster.

Pathway Mr. Schneider gave an overview of the report he had presented earlier that day which combined the professional findings of the appraiser and planner. He complimented Council on their thoroughness, then reviewed the questionnaire results.

He explained that to relieve the adjacent property owners of liability, the Village would have to buy the land required for the pathway. The preliminary estimate is \$350 a frontage foot, or \$7,000 plus damages, an approximate \$15,000 total.

It will be necessary to move a telephone pole, also some manhole covers, and to provide drainage. For the entire pathway, to connect with Evening Street and land acquisition, the best estimate at this

time is \$64,900. This figure includes the \$3,000 already allocated.

Earlier in the meeting, the Mayor had circulated both an attendance roster and a sheet for those residents to sign who wished to speak. She now called on the latter persons, allowing each a maximum of five minutes.

Twenty persons spoke, approximately half opposed to and half in favor of the pathway. Assorted concerns were expressed, many having to do with money.

The Mayor addressed concerns which had been raised during the comments. Mr. Schneider addressed several issues raised. One concerned Worthington's portion of the sidewalk expense on their side of the pathway. \$30,000, he said.

Mr. Janssen explained that in the early 1940s, then-Mayor Fred C. Berkhemer and Council were faced with threats of outsiders' wanting to connect with such streets as Pioneers Court. They voted to deed these streets fifty-fifty to the adjacent property owners. These people have maintained and paid taxes on this property for over 40 years. Mr. Janssen feels the estimates are low, and urges bringing the question to the residents for a vote.

Mrs. Huestis explained that if the question is put on the ballot, we would need a specific design with costs, and be clear about coordinating with thre City of Worthington, including expense on the Worthington side, and how these would be handled.

Mr. Schneider said he had talked with Worthington officials and they had no objection to our doing the pathway. To determine what they would require for the north sidem the question would have to go before their Council. Additionally, the property owners would need to be consulted to determine costs. We would need a plan. Edsall & Associates, the planners, estimate an additional \$2,000 would be required, and Gary J. Secker, the appraiser, \$3,000, to go forward and get the specifics necessary to put the question on the ballot.

Mr. Merrick raised the question if it is appropriate for us to use the street fund monies for the pathway? Mr. Schneider will present a written opinion to Mr. Golonka who will conduct an investigation based on his report.

Mrs. Kochalski made the motion that we proceed with exploring a less-expensive plan, and speak with Worthington officials to see if they are willing to cooperate cost-wise; said exploration costs should not exceed \$1,000 additional funds. Mrs. Call seconded. She, Mrs. Kochalski and Mr. Merrick voted aye, Mrs. Anderson voted nay and Mr. Janssen abstained. Mr. Owens was not present at this time. The motion did not carry.

SOLICITOR'S REPORT

When Mr. Golonka checked with the Sharon Township Fire Department, he found they have no jurisdiction over house numbers Ensuing discussion stressed the importance of having coherent numbers for emergency vehicles. The Mayor suggested that rather than pass an ordinance, we investigate other possibilities and perhaps paint curb numbers for all residents at Village expense. Mr. Golonka will check to see if this is all right to do.

OLD BUSINESS

Mrs. Kochalski reported receiving calls from residents concerned over peoples' not obeying the Stop signs on West Southington, including a Worthington Police cruiser. She urged stronger enforcement prior to having to install speed bumps to slow drivers. Mrs. Huestis will ask the Police to start ticketing offenders.

Mrs. Kochalski also brought up the directory discussion which was inconclusive at the December meeting. Following discussion, Mrs. Kochalski moved we accept Pat Kiefner's offer to publish the Riverlea Directory, using red notebook-style covers, over a three-year period. Mrs. Anderson seconded and the favorable vote was unanimous. Additionally, we will offer residents the option of also having first names listed, if it is all right with David G. Moore. If approved, Mrs. Kochalski will work with Mrs. Stabler in contacting residents about this.

NEW BUSINESS

Mrs. Wallace presented No. 630, The Annual Appropriations Ordinance and Declaring an Emergency. By this time, both Mr. Merrick and Mr. Owens had had to leave the meeting, therefore the three-fourths required for a vote was not possible. Mrs. Huestis called a Special Meeting for 9:00 a.m. Saturday, January 21, at 31 West Southington Avenue in order to vote on the ordinance.

As Monday, February 20 is Presidents' Day, the next meeting will be held on Tuesday, February 21 at 275 West Southington.

There being no further business, the Mayor called for a motion to adjourn. Mrs. Call so moved, Mrs. Anderson seconded and all voted aye. the meeting was adjourned at 9:50 p.m.

RE: Memo regarding the proposed walkway

At the last Council meeting several questions were raised regarding the proposed walkway in the Village of Riverlea. Specifically I was instructed to meet with area residents and Ms. Edsall to discuss various alternatives to the proposed plan to see if a less expensive design could be proposed. I was also to meet with representatives from the City of Worthington to gain their input. I will attempt to summarize these issues as well as other matters that have recently been brought to my attention.

DESIGN ALTERNATIVES:

At the meeting with Edsall & Associates the proposal was discussed. The meeting was attended by Deborah Edsall, Dan Noble, Ed Kochalski, Randy Bennett and me. Everyone generally agreed with the proposed sidewalk on the East side of Pioneer Court as opposed to the unmarked gravel walkway. The residents felt that there was no need to include storm sewer costs (\$4,780.00) as any such problem is not caused by the sidewalk. Ms. Edsall did agree that this particular sidewalk would not cause any additional drainage problems. The residents also felt that the project should not in anyway be contingent upon construction in the City of Worthington.

MEETING WITH CITY OF WORTHINGTON:

A meeting with the City of Worthington was held on April 4, 1989. The Worthington officials were generally supportive of the walkway with the understanding that they were not speaking for City Council. They made it very clear that their support was contingent upon two factors which include:

- 1. The walkway in Riverlea must connect to emisting sidewalks in Worthington. Any effort to construct the walkway without connecting the same to existing sidewalks would be opposed. They saw serious liability problems in allowing the walkway to empty into one of their streets.
- 2. They were not in a position to recommend to City Council that Worthington funds be used for this project.

They were going to contact the Worthington residents who would be impacted by the project to get their input.

The Worthington officials did believe that the proposed cost estimates were too high.

REVISED ESTIMATE OF COSTS:

Land Acquisition:

The appraiser is now recommending that we acquire the twenty foot wide strip currently known as Pioneer Court and that the walkway be constructed on the east four feet of this strip of land. Additionally, the four foot walkway should be extended north on the O'Neil property from the termination of Pioneer Court to the north property line.

Estimated Cost.....\$9,000.00

Construction Cost:

Assuming that Edsall's figures are too high the construction cost of the walkway will be \$3.50 per LF of 4' sidewalk. I have also eliminated all drainage work and reduced the amount for landscaping and vegetation clearance. This produces the lowest reasonable cost estimate I can give to Council without actual specifications.

EXPENDITURE OF FUNDS OUTSIDE OF THE JURISDICTION

As a result of the meeting with Worthington officials I did research the question of whether the Village could spend Village funds outside of its jurisdictional limits.

The general rule is that the Village's authority is limited by its boundaries unless there is specific statutory authority otherwise. While there are various statutes granting Council authority to spend funds outside of the Village none cover the situation herein. Therefore I am not currently in a position to state that it would be a legal expenditure to construct a walkway in Worthington. This opinion might change if it were a joint project that would benefit both jurisdictions and both jurisdictions were sharing the costs. This does not currently appear to be the position of Worthinton officials. No position has been taken by their City Council.

BALLOT:

There has been some talk that this matter be placed on the ballot by the Village Council. I have researched this question.

It is my opinion based on existing statutes and case law that Council cannot use the general election to conduct a public opinion poll to determine voter attitudes. Council must adopt the ordinance in its normal fashion regarding what is to be done regarding the walkway. The issue gets to the ballot only by initiative or referendum. If Council fails to adopt an ordinance the population can by initiative. If Council adopts an ordinance the population can overturn it by referendum. Both of these procedures must be started by the electorate.

Council met in the Multi-Purpose Room, Worthington Community Center, 374 Highland Avenue. Mayor Martha E. Huestis called the meeting to order at 7:10 p.m. Dan E. Owens, Council President, Patricia A. Anderson, Penny Call, Jacqueline B. Kochalski, and David A. Merrick were in attendance. Also present were Loretta C. Wallace, Clerk-Treasurer; Kenneth A. Golonka, Jr., Solicitor; Ted. M. Beegle, Building Commissioner-Inspector; and Charles A. Schneider, Attorney for the Ad Hoc Committee.

Residents present were Mary Arter, Linda Beegle, Randy Bennett, Donald H. Birney, Jr., Steve and Betty Case, Joanne Claire, Tom and Maxine Clancy, Mary Jo Cusack, William S. and Naomi S. MINUTES OF JANUARY MEETINGS

After lengthy criticisms of the January 18 meeting minutes, it was decided Mrs. Stabler should re-write them and re-submit them to Council. In light of this, consideration of the January 21 minutes was deferred so they could be voted on in order.

CLERK-TREASURER'S REPORT

Mrs, Wallace distributed the Financial Report and a listing of the January bills. Mr. Owens made the motion, Mr. Merrick seconded and all voted in favor of approving payment of the following:

MAYOR'S REPORT

Mrs. Huestis reported a street sign once missing is now in her garage. Mr. Edwards offered to re-install it. She noted the No Parking sign by the Pump House is missing.

Discussion of the rash of recent burglaries followed. Mrs. Huestis referred to her letter with helpful materials which had been distributed to every household. She stressed do not hesitate to call

the Police. There were extra copies of the latter available at the meeting, she reported.

Mr. Owens had talked with Columbus Southern Power about what's involved with area lighting for residents. This would be the individual home owner's responsibility rather than the Village's. He found that costs vary from \$8.50 to \$15.00 a month. Interested persons may telephone 464-7700 for more information.

Tha Mayor read the report for the Marshal.

COMMITTEE REPORTS

Mr. Owens reported a water line had broken on Melbourne Place. The City of Columbus Water Department had responded.

SOLICITOR'S REPORT

Mr. Golonka explained that after discussion with Bituminous Paving Systems, Inc. personnel, an agreement had been reached to split the additional bill (\$1,384.50) half and half. They have written a letter to this effect. He, the Mayor, and Mr. Beegle feel this is legitimate.

NEW BUSINESS

Ordinance No. 631, to wit: "An Ordinance to Provide Legal Counsel for the Village of Riverlea and to Declare an Emergency" was read. Mr. Owens moved and Mrs, Kochalski seconded, to suspend the three readings. The favorable vote was unanimous. The motion to declare an emergency and adopt Ordinance No. 631 was made by Mrs. Anderson, seconded by Mrs. Kochalski and unanimously approved.

OLD BUSINESS

Mr. Owens told that even though we're not under contract with Accurate Plumbing, they have made two inspections.

Pathway Seventeen people asked to speak, among these, three from "The Path Committee" who made their presentation.

Messrs. Noble, Kochalski, and Bennett referred to the nine member "The Path Committee" report and its three proposals which had been distributed to every household. Their purpose is to demonstrate a plan for an economically feasible pedestrian pathway. "The Path Committee" favors Option One, the most expensive at \$9,695

to \$11,995, yet considerable less than the plan of \$64,900 previously reported.

Many spoke urging bringing the decision to a ballot, yet one urged Council to decide and save the costs of bringing the issue to a vote. The need for a catch basin was stressed by Mr. Edwards noting the slope of the Moose lot causes run off. He recommended Council have a representative at the Moose lot proceedings. Several encouraged bringing this issue to fruition as it has been pending almost two years.

Mr. Schneider reminded Council it needs to decide about eminent domain and about the ballot. If it goes to a ballot, there would need to be a specific plan with dollar figures. He would like to confer with Edsall & Associates, and would be willing to work with Mr. Noble and Mr. Kochalski. The Mayor asked if Mr. Noble might also meet with Edsall.

Mr. Owens made the motion that the pathway discussion carry on for another month so that Mr. Schneider and representatives of "The Path Committee" might meet and report back to Council in March. Mrs. Call seconded and all voted aye.

It was noted that the report circulated by "The Path Committee" had been confusing to residents who did not understand this was not a body approved by Council. They were instructed to use some other name, perhaps "Concerned Citizens for a Path Committee," in order to clarify.

At 9:00 p.m. the Mayor called for a brief recess at which time many of the quests left.

CONCLUDING BUSINESS

When the meeting was reconvened at 9:05 p.m., the Solicitor explained that Mr. Schneider and he agree that the Village should not appropriate additional street fund money for the Pathway or sidewalk. The Building Commissioner-Inspector's report concerned one permit; he gave a copy to the Clerk-Treasurer.

The Mayor then called for any additional remarks under Old or New Business. For the former, Mrs. Call told of no success so far regarding painting house numbers on curbs. It was suggested she contact other charitable groups. Under the latter, Mrs. Kochalski asked if this location had been satisfactory for the meeting. The response was affirmative and she was asked to engage the same room for the third Mondays, starting at 7:30 p.m., of April, May and June. Mrs. Anderson noted the Riverlea marker at West Riverglen needs a light repair. As a professional will be required, Mr. Owens will pursue this.

There being no further business, at 9:12 p.m. Mrs. Huestis called for a motion to adjourn. Mr. Merrick so moved and Mrs. Kochalski seconded.

Anderson, Harold H. Janssen, Jacqueline B. Kochalski, David A. Merrick. Also in attendance were Loretta C. Wallace, Clerk-Treasurer, Jennifer Malone, and our guest, John K. "Kenny" Francis, Director, Emergency Management Agency of Columbus and Franklin County.

MINUTES OF PAST MEETINGS

The Mayor called for additions or corrections, starting with the January 18 minutes. On Page Three, the fifth paragraph should read: Mrs. Huestis explained that if the question is put on the ballot, we would need a specific design with costs, and be clear about coordinating with the City of Worthington, including expense on the Worthington side, and how these would be handled. Mr. Owens pointed out typographical errors, then moved the minutes be approved as corrected. Mrs. Anderson seconded and all voted aye. Mrs. Huestis asked that in the future, when it is necessary for a Council member to leave during the meeting, Clerk of Council make a notation as to when exactly he or she left.

The January 21 minutes were considered next. There being no corrections, Mr. Owens moved their approval; Mr. Merrick seconded and the favorable vote was unanimous.

In the February 21 minutes, Page Two, under Old Business, delete "Of the 17, six were in favor, ten oppossed, and one non-commital about the pathway." and in the third paragraph, delete ", proponents,". One Page Three, Concluding Business, the first sentence should read: "When the meeting was reconvened at 9:05 p.m., the Solicitor explained that Mr. Schneider and he agree that the Village should not appropriate additional street fund money for the pathway or sidewalk." Mr. Janssen moved for the approval of the minutes as corrected. Mrs. Anderson seconded and all voted aye.

MR. FRANCIS

The Mayor deviated from the Agenda to allow Mr. Francis to speak and introduced him. He told of his agency, formerly called Disaster Services, reminded that the Mayor and members of Council are responsible for the civil preparedness of the Village, and answered questions. He introduced Resolution No. 633, to wit: A Resolution to Enter into a Written Agreement with Other Political Sub-divisions to Establish a County-wide Emergency Management Agency, Pursuant to Chapter 5915 of the Ohio Revised Code, and to Continue to Provide Financial Support and Funding Pursuant to the County-wide Agreement. Mr. Owens made the motion to accept said resolution, Mrs. Kochalski seconded, and all voted aye. Mr. Francis then left.

CLERK-TREASURER'S REPORT

Mrs. Wallace distributed the Financial Report and a listing of the February bills. Mr. Janssen moved, Mr. Owens seconded and all voted in favor of paying the following bills:

The Mayor reported she had called for snow and ice removal at the time of our most recent snow, and noone came. She had seen John Circle and mentioned this to him. Mrs. Kochalski questioned if anyone had investigated alternatives. The Mayor asked her to do so.

COMMITTEE REPORTS

Mr. Owens said that he will follow up in the Spring to be sure the place on Melbourne which was dug up due to the water main problem gets smoothed over.

Parks Mrs. Anderson noted we had half the ravine park cleaned for approximately \$400 and asked if we could afford to clean the other half now.

M.O.R.P.C. Mrs. Huestis had attended a meeting.

MARSHAL'S REPORT

The Mayor read the February Worthington Police report.

OLD BUSINESS

Mrs. Stabler reported on the new directories. Mrs. Kochalski mentioned the need to thank Pat Kiefner for providing them. The Mayor agreed and asked her please to do so.

Mr. Owens reported having met with John Ludwig of Accurate Plumbing. Even though we don't have a contract with them, they have continued to do inspections. Mr. Owens has walked down each month to check. He recommends we pay them for at least January, February, March and April at their usual \$70 per month fee, or \$280. Mr. Janssen put this in a motion which Mr. Merrick seconded. All voted in favor of paying Accurate Plumbing the \$280.

NEW BUSINESS

Mrs. Stabler read Ordinance No. 632, to wit: An Ordinance to Provide for the Collection and Disposal of Garbage and Rubbish within the Village and to Declare an Emergency. Mrs. Kochalski moved to suspend the three readings; Mr. Janssen seconded and all voted aye. Mr. Merrick made the motion to declare an emergency and adopt Ordinance No. 632. Mr. Owens seconded and the unanimous vote was favorable.

Mrs. Anderson noted the Village needs a new United States flag. Mrs. Huestis will contact the offices of Representative Chalmers Wylie as he has donated flags to us in the past.

As it is not possible for Charles A. Schneider, attorney for the Ad Hoc Committee, to attend Monday evening meetings, the Mayor has called a special meeting for Thursday. April 6, 8:00 p.m., at the Worthington Community Center to discuss the Pathway.

There being no further business, at 9:12 p.m. the Mayor called for a motion to adjourn. Mrs. Kochalski so moved and Mrs. Anderson seconded.

The special meeting of Council called to discuss the proposed pathway was held at the Worthington Community Center, 374 Highland Ave. Mayor Martha E. Huestis called the meeting to order at 8:09 p.m. All Council members were present: Dan E. Owens, President, Patricia A. Anderson, Penny Call, Harold H. Janssen, Jacqueline B. Kochalski and David A. Merrick, as well as the Clerk-Treasurer Loretta C. Wallace and the Solicitor, Kenneth A. Golonka, Jr. Also in attendance was Charles A. Schneider, Attorney for the Ad-Hoc Committee.

The Mayor called for Mr. Schneider's report on his meeting, along with Dan Noble, Ed Kochalski and Randy Bennett, with Edsall & Associates, also with representatives of the City of Worthington. During the former meeting, he said that all, including Deborah Edsall, agreed on the value of a "curbed concrete sidewalk."

Mrs. Huestis had accompanied Mr. Schneider for the meeting with Worthington administrators, not Worthington City Council. For safety concerns and liability reasons, they said they would be generally supportive if the sidewalk connected with the existing sidewalk at Evening St. They also said they were not in a position to recommend that Worthington funds be used for the project. They will contact Worthington residents who would be impacted by the project to get their input.

Mr. Schneider then presented a new figure for the proposed pathway which he deemed the lowest reasonable cost estimate he could give Council without actual specifications. To acquire the 20-foot strip between the residences at 142 and 156 W. Riverglen Dr., construction costs, legal costs and a figure for contingency total \$29,785.00.

As a result of the meeting with Worthington administrators, Mr. Schneider had researched the question of whether the Village could spend Village funds outside its jurisdictional limits. He cannot say it is legal, Mr. Schneider concluded. As regards the

ballot, he cited an example of a Cleveland situation, the conclusion of which was the ballot cannot be used as an opinion poll.

Mrs. Huestis asked Mr. Schneider for an approximate figure he felt would be needed in order to put this issue on the ballot; his reply was \$5,000.00. She thanked him, then she addressed the school bus issue. She had spoken with the President of the Worthington School Board who said she would try to obtain an answer. She then asked Mrs. Wallace if the Village had the money necessary to put this issue on the ballot. She assured her funding is available.

The Mayor called for a motion. Mrs. Call moved that the Village spend up to \$5,000.00 to proceed to put the issue on the ballot. Mrs. Kochalski seconded. Mrs. Huestis then called for discussion of the motion.

Extensive discussion followed with a number of residents expressing concern. Council members also spoke, though time was getting short before we needed to vacate the room. The Mayor invited a motion to declare an emergency and suspend the required three readings. Mrs. Call's motion to this effect died for lack of a second.

The Mayor explained that a second reading could be held at the regular meeting of Council in April, the third, the May meeting. She then adjourned the meeting at 9:35 p.m.
